

# Case Western Reserve University-Affiliated Dietetic Internship Programs Outstanding Alumni Award

The Outstanding Alumni Award is presented annually to one alumnus from each of the dietetic internship programs (Public Health Nutrition Dietetic Internship, Louis Stokes Cleveland VA Medical Center Dietetic Internship, University Hospitals Cleveland Medical Center Dietetic Internship) affiliated with Case Western Reserve University Department of Nutrition, who has made outstanding contributions in one or more of the following ways:

- Accomplishment in dietetics and in the emphasis area of their program
- Service in local, state, or national professional leadership
- Service in support of dietetics education.

## *Eligibility*

In order to be eligible, nominees must:

- granting.
- Not have previously been recognized with the CWRU-Affiliated DI Outstanding Alumni Award.

## *Nomination Process*

- Nominations, or self-nominations, may be made at any time throughout the year.
- In order to be considered for awarding in December of a specific year, nominations must be received by 5 pm EST on July 31 of that same year.
- Nominations received after that cutoff will be considered for the next review cycle.
- Nominations MUST be sent to [nutrition@case.edu](mailto:nutrition@case.edu) using the attached form along with a resume/CV and a letter of recommendation.
- Because nominations require a resume/CV, you will likely need to let the nominee know that you are nominating them.
- Letters of recommendation may be written by anyone (except the nominee or members of the award committee) who is able to speak on the nominee's achievement of the award criteria.
- The nominator's identity will not be tied to the nomination form.
- Nominations will be kept on file for 3 review cycles, and will keep the same score each year unless nominators submit updated information by July 31.
- Nominations will be reviewed annually in August by a committee for each program.

## *Selection and Recognition*

- Only one award will be made per program per year.
- The award winner will be announced in September.
- An award plaque will be formally presented at intern graduation in December of each year.
- Awardees will be invited to graduation to receive their plaque and make a short set of thank you comments, or if unavailable to attend in person will be invited to record an equivalent video address for playback at graduation.
- Awardees are responsible for their own travel costs/arrangements to accept the award in person.
