Case Western Reserve University does not utilize the IDOC system through College Board.

CONTINUING/CURRENT CWRU STUDENTS: Only if notarized, please upload the completed form online by logging into the My Financial Aid Portal, clicking on the menu in the upper left corner, clicking on the Documents & Messages option and locate the statement of Educational Purpose upload.

- 1. Statement of Educational Purpose (1 page) Submitted in person, unless notarized
- 2. Proof of Identity using an unexpired valid, government-issued photo identi"cation such as, but not limited to, a driver•s license, other state-issued ID, or passport Original document is required when the form is completed, whether in person or notarized. A copy of the document will be made when completed in person, or must be submitted with the notarized statement.
