Application Instructions

APPLICATION

Competition for the entering class is high. When we review files, our question is this: Is a candidate ready to meet the intellectual challenges of our program? The admissions committee evaluates each applicant's file, looking carefully at the candidate's undergraduate grade-point average and LSAT score as well as at other, non-quantitative factors, such as level and difficulty of undergraduate coursework, writing ability, graduate coursework (if applicable), leadership potential, and work experience.

Admission Policy

Our selection process, while rigorous, is not rigid. We insist upon diversity in our student body because we believe that the entire law school community benefits from it. We will consider with sensitivity any information about a candidate's special circumstances.

Admission Requirements

To enroll in the JD program, a student must have a bachelor's degree from an accredited institution. We encourage undergraduates interested in law to gain a broad educational background and to choose challenging courses requiring critical thinking and logical analysis, such as history, economics, philosophy, and accounting. We particularly urge students to choose courses in which they will develop strong writing skills.

Standard of Truthfulness and Full Disclosure

As future members of the legal profession, applicants are expected to possess the highest standards of ethics and character. All applicants, including those who enroll in the $\mathfrak{D}\zeta$ $\mathring{\mathcal{C}}$ $\mathring{\mathcal{C}}$

In addition, we adhere to and participate in the Law School Admission Council's Rules Governing Misconduct and Irregularities in the Admission Process.

Admission Procedures

- Take the Law School Admission Test (LSAT). Although we recommend that you take the LSAT in the summer or fall
 before applying to law school, we do accept scores for tests taken closer to the start of law school. We will also consider
 applicants who take the LSAT in June for a spot in the class entering that August on a case by case basis. We look at all
 LSAT scores with the emphasis on the highest score. You may register for the LSAT by contacting LSAC by phone at
 215.968.1001 or via the web at LSAC.org.
- Register with LSAC's Credential Assembly Service (CAS). Follow the necessary instructions to arrange for the Credential
 Assembly Service to send us your letters of recommendation and its analysis of your undergraduate and graduate school
 transcripts. Đǿմ«Ã½ School of Law's Credential Assembly Service code is 1105.
- Submit a completed application, which may be obtained:
 - from our website at <u>law.case.edu</u>; or
 - from LSAC, as part of its electronic applications service

We accept applications that have been prepared using the Law School Admission Council's electronic applications service. This service allows you to use your computer to efficiently fill out applications for all ABA-approved law schools. The application fee for applications electronically submitted to Case Western via the electronic applications service is waived.


Applications submitted to LSAC for transmission to this law school will be considered postmarked on the day they are electronically submitted.

Alternatively, you may submit a completed paper application, available for download at the Admissions section of our website at law.case.edu. The application fee for paper applications is \$40.

The Timetable

First Year JD Decision Process

Our priority application deadline is December 1; late applications will be considered after that date, on an individual basis. Beginning in September we take action on the applications. We have a rolling admissions policy; that is, as decisions are made, applicants are notified. We make most admission decisions between September 1 and November 30, at which time we may establish a wait list. As vacancies occur up to the date of registration we draw the best-qualified candidates from the wait list.

Transfer Students

Students currently enrolled in an accredited law school may apply for admission with advanced standing. The number of transfer applicants that we accept varies from year to year, depending on the number of spots available in the second-year class. The primary factor in the admission decision is prior law school performance; undergraduate grades and LSAT score will also be considered. In addition to the application and documentation required of JD candidates, transfer applicants must submit: (a) two letters of recommendation, (b) an official transcript of law school work completed, (c) a letter of good standing from their dean, and (d) an official class rank. Transfer applicants must submit an original Credential Assembly Service Law School Report from the Law School Admission Council; we cannot accept a copy of your law school report from your current school. Application deadline for entry spring semester: December 1; For entry fall semester, Early Action Program: March 30; Regular Action Program: July 1. Note, for fall semester, please use the Fall Application.

The Application Packet

We consider an applicant file complete once we have received an application with all required components, including the application fee (waived for applications submitted electronically), personal statement, résumé, and two letters of recommendation (required), as well as a law school report from LSAC's Credential Assembly Service. Include your name and LSAC account number on any supplemental enclosures and identify the question number to which they correspond.

Letters of Recommendation

Two letters of recommendation are required and are to be submitted through LSAC. This service is included in your Credential Assembly Service registration. Your documents will be forwarded to us along with your law school report. To use this service, follow the directions for submitting letters outlined at <u>LSAC.org</u>.

SPECIAL APPLICATION PROCEDURES

International Students

We require that international transcripts be submitted through the Credential Assembly Service (CAS) offered through the Law School Admission Council. If you completed any postsecondary work outside the US (including its territories) or Canada, you must use this service for the evaluation of your international transcripts (exception: if you completed the international work through a study-abroad, consortium, or exchange program sponsored by a US or Canadian institution, and the work is clearly indicated as such on the home campus transcript). This service is included in the Credential Assembly Service subscription fee. An International Credential Evaluation will be completed by the American Association of Collegiate Registrars and Admissions Officers (AACRAO) and will be incorporated into your law school report. If your transcript is not issued in English in its original form by your institution, you will need to submit a TOEFL score as well. To do this, you must contact the Educational Testing Service (ETS) and request that your TOEFL score be sent to LSAC. LSAC's TOEFL code for the Credential Assembly Service is 8395. Your score will be included in the International Credential Evaluation document that will be included in your law school report.

To use the Credential Assembly Service, log in to your online account and follow the instructions for registering for the service. Be sure to print out a Transcript Request Form for each institution and send it promptly to them. More time is usually required to receive international transcripts.

Visiting Students

Students currently enrolled in other law schools who wish to take courses here for credit toward the other school's degree requirement may apply to be visiting students. In addition to the application and documentation required of transfer applicants, visitor applicants must submit: (a) a letter from their dean indicating that the school will accept academic credits from ĐÇ¿Ō´«Ã½ School of Law, and (b) a letter explaining their reasons for wishing to take courses here. Application Deadlines: for entry spring semester: December 1; for entry fall semester: July 1. Note, for fall semester, please use the Fall Application.

Dual-Degree Candidates

Applicants to a dual-degree program must apply separately to—and be admitted by—both the law school and the school that will grant the second degree. This means that applicants must meet the application and admission requirements of each school. To get information about the other programs, review the Dual Degrees section of our website at case.edu/law.

Character and Fitness - Continuing Obligation to Disclose

Because of the high ethical standards to which lawyers are held, the failure to disclose an act or event such as the ones described in the Character and Fitness questions is often more significant and leads to more serious consequences than the act or event itself. Failure to provide truthful answers or failure to inform the admissions office of any changes to your answers may result in revocation of admission, disciplinary action and/or dismissal by the law school, and/or denial of permission to practice law by the state in which you seek admission.

Each of the character and fitness question requires a "yes" or "no" answer. If your answer is "yes" to any of the questions, you are required to supplement your response with a full explanation of the circumstances, including dates. You also have the obligation to notify the School of Law if there is any change in the information contained in those documents.

All matters must be reported, even if they were dismissed, expunged, or the records sealed! Even if you were advised differently in the past, you are required to disclose all matters in this application process.

Admission to a State Bar

In order to be eligible to take the bar exam in any state, you will need to complete an application. In addition to a bar examination, there are character, fitness, and other qualifications for admission to the bar in every U.S. jurisdiction. Applicants are encouraged to determine the requirements for any jurisdiction in which they intend to seek admission by contacting the jurisdiction. Addresses for all relevant agencies are available through the National Conference of Bar Examiners.

The application questions will vary from state to state, but generally will require you to disclose whether you have been subject to any criminal or disciplinary proceedings. Different states handle such offenses differently. If you would respond to such questions in the affirmative, you should contact the Board of Bar Examiners of the states(s) in which you wish to practice law in order to establish the impact of your offense on your eligibility to practice law in that state. Any discrepancy between your responses on your applications for law school admission and for admission to the bar may be an impediment to your admission to the bar in many states.

AFTER APPLYING

Acknowledgement of Application

After receiving your application packet, the Office of Admissions will send you instructions by email on how to access the Applicant Online Status for the continual up-to-date status of your file. Most correspondence will be done via email so please keep us informed of any changes in your email address.

Credential Assembly Service Law School Report

Upon your submitting your application, we will automatically receive your Credential Assembly Service Law School Report once you have subscribed to LSAC's Credential Assembly Service.

Deposit Deadlines

An offer of admission must be accepted before the date indicated as the deadline; if not, it may be withdrawn by the law school. Accepted applicants will be required to submit a single \$500 spring start deposit. Deadlines for deposits are strictly enforced. Deposits are non-refundable. Please note the first choice option is an agreement between the applicant and our School of Law. The applicant is making a commitment to enroll at Θ \circ\tilde{O}^\circ\tilde{A}\chi_2\$ School of Law the spring semester immediately following our offer of admission.

Transcripts

All students are required to have obtained their four-year bachelor's degree prior to matriculation. By January 15, every student must submit two official transcripts to the School of Law from undergraduate degree-granting institutions certifying receipt of a bachelor's degree and one official transcript from a graduate degree-granting institution, if applicable. All entering students must also have a final transcript evidencing receipt of a bachelor's degree on file with LSAC prior to matriculation. Failure to adhere to these requirements may result in withdrawal of the offer of admission, suspension or dismissal from the School of Law.


